

How to Make Online Tax Payments with Your Checking/Savings Account

Please note that these instructions for paying online with a checking/savings account, which is free of charge. You are able to pay using a debit/credit card for a fee. You can find this information on the [IRS](#) or [Oregon](#) websites.

How to Pay the IRS Online


If filing jointly with your spouse, please enter the information for the person listed first on the return.

Note that this is for personal tax payments. If you own a business and are filing as a sole proprietor or single-member LLC your Federal tax payments are still considered personal tax payments.



How to Pay Portland/Multnomah County Business Tax Online

You do not need to create an account or log in to pay!
Click on the Business option. Note that, unlike the Federal and State payments, this is a business payment and filed as a business. It can be counted as a business expense for next year.
